Margie McFarland — Asked to be on the agenda to see what steps have been taken about the grievance filed about Alderwoman Branch and the Reprimanded that followed this. Justin Pruitt (City Attorney) stated she is on the agenda to appeal the Reprimanded and that her comments needed to be addressed. Margie McFarland stated that she wanted to know about the appeal she submitted regarding her grievance. She also stated what steps are going to be taken to make sure this doesn't happen in the future to someone else and mentioned that she feels harassed and bullied. What's the proper chain of command? Justin Pruitt (City Attorney) stated the clarification of the personnel policy. A letter of reprimand can be issued under the Personnel policy, and then you can appeal. The next step can be unpaid leave or dismissal, or termination. He also stated that she was issued a reprimand letter by the mayor and placed on file. Mr. Pruitt also stated that the letter must not be issued to the council.

Margie McFarland stated she was here to appeal the reprimand letter, which was based on hearsay from a co-worker (Beatrice Compean) telling Mrs. Branch, a lie about something she said. So basically, she was there because of hearsay and nothing factual. And this was the reason for her appeal. Margie McFarland also stated that Alderwoman Branch got her husband, Mayor Branch, to write her up. Alderwoman Branch stated that Ms. Compean was not the one who told her about the comments, and when she spoke to Margie McFarland agreed with Alderwoman Branch regarding the comments which were said. Margie McFarland said it was an opinion she said. Alderwoman Branch made a statement to apologize to Margie McFarland. And Margie McFarland states, that we should be able to speak freely.
